Subject: Permit Fee Schedule

Adopted by the Board of County Road Commissioners on 8/11/04

Revised by the Board of County Road Commissioners: 4/18/2007, 2/24/2016, **2/22/17**

Pursuant to Act No. 212, Public Acts of 1980 (MCLA 224.196) and the Public Hearing held on 3/22/17 the Gladwin County Road Commission establishes the following fee schedule to recoup costs actually incurred in processing permits. The following schedule is not meant to be all inclusive in recouping all costs, and therefore may be increased to cover the actual costs incurred.

When a combination of activities is included in one permit, the fee shall be based on single highest fee for any one activity.

All work and activities in public right-of-way will require appropriate liability insurance with a statement that excludes the Gladwin County Road Commission from any liability.

* Restoration Cash Bond = minimum \$1,000 Cash Bond per cut or a minimum \$5,000 Performance Bond.

** Requires a density test from a certified inspector. Results shall be forwarded to the GCRC before paving work commences.

Residential permit fee will be waived due to the local millage.

Any and All of the above activities may need liability insurance, cash bond, and/or performance bond.

Amounts will be determined at the time of permit request by the Engineer.
