The minutes from the February 5, 2020 regular meeting were presented for approval. Motion was made by Commissioner Hinman and seconded by Commissioner Cameron to approve the minutes as presented. Motion Carried

Payment voucher 20-04 was presented for approval for payroll in the amount of \$70,572.67 and bills payable in the amount of \$320,339.96. Motion was made by Commissioner Hinman and seconded by Commissioner Cameron. Motion carried.

Bids were opened and read for Processed Road Gravel. A motion was made by Commissioner Cameron and seconded by Commissioner Brabon to award the Processed Road Gravel bids in the best interest of the Gladwin County Road Commission with all gravel meeting bid specs:

Craig Mills, Sage Township Road Committee Member asked about the Chappel Dam Road paving bid.

Chris Meissner, Sage Township Committee Member reported a pot hole on Pratt Lake Road.

We had positive reports on the last snow storm clean up from Karon Hoffman, Clement Township; Tim Mester, Billings Township; John Krchmar, Gladwin Township; Andy Schneider, Grim Township; and Dan Gonzales, Butman Township.

Cash Balances were provided and reviewed.

An update was given regarding the tax requirements with the 457 plan through MERS.
