Payment voucher 22-09 was presented for approval for payroll in the amount of \$69,045.28 and bills payable in the amount of \$59,820.61 and payment voucher 22-09-2 in the amount of \$15,750.00. Motion was made by Commissioner Hinman and seconded by Commissioner Cameron. Motion Carried.

"A motion was made by Commissioner Cameron and seconded by Commissioner Hinman that Chairman, David Greaves and Vice-Chairman, Charles Hinman be authorized to sign contract #22-5104, Job #206071CON and 206073CON with the Michigan Department of Transportation to hot mix asphalt milling and resurfacing of the bridge wearing surface, replacement of the waterproof membrane, concrete surface coating and abutment backwall joint waterproofing of the structure #2896 which carries Beaverton Road over the Tobacco River, Section 11, T17N, R02W, Beaverton Township, Gladwin County, Michigan; and structure #2917, which carries Glidden Road over the Tobacco River, Section 07, T17N, R01W, Tobacco Township, Gladwin County, Michigan; including hot mix asphalt approach work, concrete curb and gutter, substructure pier cap patching, pile bent repair, structural crack repair and deck joint repair; and all together with the necessary related work."
