

**GLADWIN COUNTY BOARD OF ROAD COMMISSIONERS**

**MEETING MINUTES OF  
November 9, 2022**

The regular meeting of the Gladwin County Board of Road Commissioners was held on Wednesday, November 9, 2022, at 9:30 a.m.

The Pledge of Allegiance was recited.

The minutes from the October 26, 2022, regular meeting was presented for approval. Motion was made by Commissioner Cameron and seconded by Commissioner Hinman to approve the minutes as presented. Motion Carried.

Payment voucher 22-23 was presented for approval for payroll in the amount of \$72,523.12 & bills payable in the amount of \$837,835.94 & 42,969.00. Motion was made by Commissioner Hinman and seconded by Commissioner Cameron. Motion Carried.
