MEETING MINUTES OF January 18, 2023

The regular meeting of the Gladwin County Board of Road Commissioners was held on Wednesday, January 18, 2023, at 9:30 a.m.

The minutes from the January 4, 2023, regular meeting was presented for approval. Motion was made by Commissioner Hinman and seconded by Commissioner Cameron to approve the minutes as presented. Motion Carried.

Payment voucher 23-02 was presented for approval for payroll in the amount of \$74,744.51 & \$5,658.39 and bills payable in the amount of \$444,065.73 & \$27,500.00. Motion was made by Commissioner Hinman and seconded by Commissioner Cameron. Motion Carried.

The board and manager thanked Steve Badger for his years of service and congratulated him on his retirement this coming Friday.

Jim Wyniemko gave the engineer's report.
