MEETING MINUTES OF April 3, 2019

The minutes from the March 20, 2019 regular meeting were presented for approval. Motion was made by Commissioner Hinman and seconded by Commissioner Brabon to approve the minutes as presented. Motion Carried

Payment voucher 19-07 was presented for approval for payroll in the amount of \$62,196.14 and bills payable in the amount of \$239,683.67. Motion was made by Commissioner Hinman and seconded by Commissioner Brabon. Motion carried.

Keith Cousineau, Grim Township Supervisor, discussed last year's projects, current drainage issues and conditions of roads due to loggers.

Karon Hoffman, Clement Township Supervisor thanked us for the great job we do with the gravel roads.

Walter and Judy Lentz, Sage Township residents asked about the drainage on Wagarville Road east of Pratt Lake Road. They also thanked us for the grading of the gravel roads.

Kevin VanTiem, Buckeye Township Supervisor stated that everything is going well in his township.

Larry Grell, Billings Township Road Committee discussed routine maintenance in Billings Township.

Gas & Weight Receipts were reviewed.

We received a notice of approval from the Michigan Department of Treasury regarding the PA 202 Corrective Action plan for our Retirement and OPEB plans.
