

**GLADWIN COUNTY BOARD OF ROAD COMMISSIONERS**

**MEETING MINUTES OF  
July 24, 2019**

The regular meeting of the Gladwin County Board of Road Commissioners was held on Wednesday, July 24, 2019 at 9:30 a.m.

The Pledge of Allegiance was recited.

Meeting was called to order by the Chairman, Steve Cameron. Present were Commissioners Cameron, Ron Brabon and Chuck Hinman, and Clerk, Heather Cameron. Manager, Dave Pettersch was absent. A list of the others attending the meeting is attached to these minutes at the road commission office.
