MEETING MINUTES OF August 21, 2019

The regular meeting of the Gladwin County Board of Road Commissioners was held on Wednesday, August 21, 2019 at 9:30 a.m.

The minutes from the August 14, 2019 regular meeting was presented for approval. Motion was made by Commissioner Brabon and seconded by Commissioner Hinman to approve the minutes as presented. Motion Carried

Payment voucher 19-17 was presented for approval for payroll in the amount of \$83,115.07 and bills payable in the amount of \$199,705.28 and payment voucher 19-17-2 in the amount of \$938,339.10. Motion was made by Commissioner Hinman and seconded by Commissioner Brabon. Motion carried.

Craig Mills, Sage Township Road Committee Member asked about graveling Lake Resort.

Karon Hoffman, Clement Township Supervisor, discussed maintenance.

Charlie Chard, Clement Township asked about the brush spraying and the I-75 sign.

Dan Gonzales, Butman Township Supervisor, discussed the cattails & trees in the ditches. He is also happy with the paving jobs in Butman Township.

Commissioner Hinman had old business to discuss regarding the drain commission billing and would like to schedule a meeting at the next Gladwin County's committee of whole.

NOW THEREFORE BE IT RESOLVED, that the Board of Gladwin County Road Commissioners approves the Application for Waiver and Plan.

Motion was made by Commissioner Brabon and seconded by Commissioner Hinman to keep Jeff Courneya in the assistant foreman position until David Greaves retires. Motion Carried
