MEETING MINUTES OF

FEBRUARY 12, 2014

The regular meeting of the Gladwin County Board of Road Commissioners was held on Wednesday, February 12, 2014 at 9:30 A.M. Meeting was called to order by the Chairman, Keith Edick. Present were Commissioners Edick, Donn, and Miller, also Pamela J. Weaver, Consultant and Dayna L. Bittner, Clerk-Secretary. The minutes from the January 29, 2014 meeting was presented for approval. Motion was made by Commissioner Miller to approve the minutes as presented. Motion was seconded by Commissioner Edick and carried.

Payment voucher 14-05 was presented for approval of payroll in the amount of \$65,534.82 and bills payable in the amount of \$187,979.44. Motion was made by Commissioner Miller and seconded by Commissioner Edick to approve the payment voucher. Motion carried.

Karon Hoffman, Clement Township Supervisor, noted that a good job was done on sanding.

Craig Mills, Sage Township resident, asked about the new turn lane not being plowed on M-61 at Chappel Dam Road.

Bob Falconberry, Sage Township resident, commented that he met with Jim Wyniemko, County Highway Engineer, on the blind driveway issue on Eagleson Road. Jim recommended moving the blind driveway sign. However, Mr. Falconberry would like to pursue having the speed limit reduced. The board recommended that he gain the support of his township board and that they would request to have a speed study done by the Michigan State Police.

Larry Grell, Billings Township Supervisor, complimented the board on the winter maintenance and also requested drainage work at the park. Tom Phillips, Billings Township Road Committee, commented that a good job was done on Martin Road.

Pam Weaver presented a letter from Doug Jacobson in regards to the ORV ordinance. Discussion took place.

Jeff Brushaber, Garage Supervisor, gave an update on equipment.
